



## Memorandum of Understanding (MOU)

Between **GRACE Charity / CDC** [P.O. Box 611, Mzuzu] and **Kelvin Msiska** [student at Daeyang College of Nursing, P.O. Box 30330, Lilongwe 3], hereafter referred to as the **Trainee**.

Purpose: The agreement is a promotion of the **Trainees** vocational training to pursue **BACHELOR OF SCIENCE IN NURSING AND MIDWIFERY** at Daeyang College of Nursing.

Agreement: The **Trainee** will get a gross support of **Malawi Kwacha 2'317.500,-** (2 Million 317 Thousand 500 Hundred) over 4 years. The assist will split up into 8 instalments as reported in the attached spread sheet. **GRACE** will pay instalments to the Colleges bank account directly. A **self-contribution of Malawi Kwacha 647'500** must be settled by the **Trainee** himself.

The **Trainee** agrees to run **2 activities** at Chipunga community per calendar year. Activities must be announced to and agreed by CDC and could cover instructive health teachings or programs on HIV and Malaria prevention. The **Trainee** further agrees to give **two short annual reports** about his vocational training progress to **GRACE** charity (at the end of every semester at the latest).


Clause: **Payment can be stopped** by CDC at any time if the **Trainee doesn't accomplish** his given obligations or **Chipunga Community doesn't stick** to their acknowledged self-contributions as: (a) renovating the headmaster house, (b) building of lavatories at Under-5-Clinic, at renovated teacher houses, and at the pre-school. Decision of interruption or stop will be made by CDC.
