Memorandum of Understanding (MOU) on RESTORATION

Between GRACE / CDC [P.O. Box 611, Mzuzu] and the Stakeholders from Chipunga Community [represented by the school management committee (SMC), village development committee (VDC), village headman (VH) Kayuni2, group village headman (GVH) Chimochimochi], hereafter referred to as the **Community**.

Purpose: During a heavy rainstorm on December 19, 2016 one school block (two classrooms) and two teacher houses were damaged seriously at Chipunga Primary School. The intent of this deal is to grant financial assistance to the **Community** who is planning to run immediate repair labour (urgency and basic material needs were explained in a letter, received on December 22, 2016).

Agreement: The **Community** will get a maximum help of **MKW 1.200'000**. The first instalment of **MKW 500'000** is ready for usage at December 28, 2016 but not until signature of this MOU. The sum is intended to buy materials for the restoration of the school block by **Community** deputies. Bernhard Schwarz shall pay these and future material requests by cheque (no cash pay-out). CDC reps will communicate the proper use of materials and the restoration progress towards **GRACE**.

Community Part: The **Community** agrees to pay for transport of all materials to Chipunga as well as for costs of labour, bricks, sand, and bamboo. Due to the accentuated emergency of this application all restoration work shall be finalized by Mid of January at the latest.

Clause: **Payments** to get the maximum amount mentioned above can be stopped if the **Community** doesn't meet its obligations. **Compliance tracking** of this agreement shall be made by CDC.
