



## Memorandum of Understanding (MOU) - EXTENSION

Between GRACE / CDC [P.O. Box 611, MZ], Mr Lovewell Mkandawile [teaching at Chipunga Primary School], hereafter referred to as the Teacher, and the Community of Chipunga, hereafter cited as the Community [represented by VH Kayuni2, SMC and PTA Chairpersons].

Purpose: The intent of the agreement is to keep the current high teaching quality at Chipunga Primary School by this transitory teaching employment (... alas Malawi government is failing).

Agreement: For additional 4 months (Sep-Dec 2017) the Teacher will get MKW 50'000 monthly (clause: if a regular employment starts, two-fold payments must be returned by the Teacher).

Community Part: The Community agrees to give support in food and accommodation to the teacher undersigned for the period of this MOU (economic value of MKW 16'000 monthly).

Clause: Payment can be stopped by CDC if the Teacher or the Community don't fulfil her/his obligations as mentioned above. Tracking and judgment of termination shall be made by CDC.


